

# PRIVACY POLICY

### 1. Introduction

Welcome to the privacy announcement of Bonti.

Bonti respects your privacy and is committed to protecting your personal information. This notification lets you know how it takes care of your data when you visit the Website and existing apps, no matter where you visit. This announcement aims to provide information about how Bonti collects and processes your personal information through your use of the Bonti Website and Applications, including any data that may be contained when using Bonti's Website or applications. Some on-site activities, such as creating a user, and account information, subscribing to a newsletter and purchasing products and services.

The Privacy Policy applies to all services of Bonti. Also read the terms of use, as it explains the conditions under which you use the services of Bonti.

# 2. Third-party links

The website and application of Bonti may include links to a third party such as websites, application stores, add-ons, and applications. Clicking on those links or enabling them may allow third parties to collect or share your data. Bonti does not control these third-party websites and is not responsible for their privacy statements. When you leave the website or programs of Bonti, it recommends you read the privacy notice of any website or application you use.

# 3. The data that Bonti collects about you

Personal data or personal information is the data that identifies a person. This does not include the removed ones (anonymous data).

Bonti uses your personal information only when permitted by law. It usually uses your data in the following cases:

- Identity data: Name, Email address, Date of birth, Address, Phone number, IP address
- Financial data: Account number, Credit card data
- Transaction data: Includes details of the payments, receipts, and other related details of purchased products and services from Bonti or its sites of partners.
- Technical data: Includes unique device ID, login data, browser type and
  - version, time and place settings, types and versions of browser plug-ins,
  - operating system and platform, and other technologies on the devices you use To access the services of Bonti.
- Profile data: Includes your username, purchases or orders you make, your interests, and preferences.
- Usage Data: Contains information about how you use the Website, mobile, applications, products, and Bonti services.





- Marketing and Communication Data: Includes your marketing preferences for Bonti and Bonti partners, your Google advertising ID (if exists), and your communication preferences.
- Collected Data: Bonti also uses and shares bulk data, such as statistical or demographic data, for any purpose. The collected data may be derived from your data, but are not considered personal data by law, as this data does not directly or indirectly reveal your identity. For example, we may collect your data to calculate the percentage of users accessing a particular feature of the website. However, if we combine or link the collected data with your data so that it can directly or indirectly identify you, we will consider the combined data as personal data used by this Privacy Statement.

We do not collect any specific categories of personal data about you (including details about race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political beliefs, trade union membership, health information, genetic and biometric data. Bonti does not collect any information about convictions and criminal offenses.

Providing the services and products requiring personal data may not be available if the member or user prevents sharing the data mentioned above. Bonti according to the law can resign from the contract.

# 4. How your personal information is collected

We use a variety of methods to collect data. especially direct interactions like filling out emails or other informational forms. This includes personal data such as:

- Request Bonti products or services.
- Create an account on the website or Bonti application.







- Subscribe to the services or publications of Bonti
- Marketing request
- Submit Feedback

# 5. Automated technologies or interactions

As you interact Bonti website or application, technical information about your equipment, browsing data, and patterns may be automatically collected. Bonti collects this personal data using cookies, server reports, and other similar technologies. Also, Bonti may collect data from the sites you may visit in which that use our cookies.

# 6. How we use your data

Bonti will only use your personal information when the law allows Bonti. It usually uses your data in the following situations:

- Where Bonti needs to provide services to you or execute a contract.
- In cases where it is necessary for the legitimate interests of the Bonti (or the interests of a third party) and your fundamental interests and rights do not take precedence over those interests.
- Where to comply with a legal or regulatory obligation.
- Where you have agreed Bonti can use your data. It collects data
  whenever you agree to do so. You have the right to cancel your
  marketing consent at any time by contacting Bonti.

# 7. Personal data use purposes

The following is a list of all of how Bonti intends to use your data, and on what legal basis it relies. Bonti also defines how the legitimate interests of the company are defined.





Note that Bonti may process your personal information for at least one legal reason, depending on the specific purpose for which it uses your data. Please contact Bonti if you need details about the specific legal basis on which it relies to process your data.

# 8. Marketing

Bonti strives to provide you with choices regarding the use of specific personal data, especially marketing and advertising. Bonti has established the following personal data control mechanisms:

# **Advertising offers from Bonti**

Bonti may use your identity, contact, and profile data to provide insight into what it thinks you may want or need, or what you may be interested in. In this way, Bonti decides which products, services, and offers may be relevant to you. If you have requested information from Bonti or you have purchased a product from the Bonti partners' applications and you want to receive it, it will provide you with marketing communications.

# Third-party marketing

Sharing your data with any external parties would happen only and only to your satisfaction.

#### Cancelation

You can ask Bonti or third parties who have sent marketing messages to you at any time by following the cancellation links in any marketing Message sent to you or by contacting Bonti at any time to cancel them.





### Cookies

You can set your browser to reject all or some of the browser cookies or to alert you when websites are setting or accessing cookies. If you disable or reject cookies, please note that some sections of this website may be inaccessible or may not work properly. For more information about the cookies you use, please refer to the cookie policy of Bonti.

# Change the purpose

Bonti only uses your data for the purposes it has stated unless it logically states that it needs to use it for another reason, and this reason is related to the original purpose. If you would like an explanation of how the processing for the new target is compatible with the original target, please contact Bonti.

If Bonti needs to use your data for unrelated purposes, it will notify you and explain the legal basis that allows Bonti to do so. Please note that Bonti may process your personal information without your consent, by the above rules, in cases where the law deems it mandatory or permissible.





# 9. Disclosure of your personal information

Bonti may share your data with data processors so that it can provide its services to you. Bonti requires all third parties to respect your personal data's security and comply with it in accordance with the law. Bonti does not allow its processors to use your data for their purposes and only allows them to use your data for specific purposes and by Bonti's instructions.

Bonti also uses cookies on its website that allow third parties to use cookies, and other storage technologies to collect or receive information from Bonti websites and other sites to analyze statistics for services and advertising.

The categories of third parties that have access to your personal information are as follows:

- Service providers, based in the EU and outside the EU, who act as processors to provide the following services to Bonti:
  - Hosting provided by Amazon
  - Security provided by Cloudflare
  - Analysis, provided by Google
  - Payment processing, provided by Adyen and PayPal
- Regulators and other officials who need to report processing activities in specific circumstances.





 Third parties to whom we may sell, transfer or merge part of our business or assets. On the other hand, we may be looking to acquire other companies or be merged with them. If there is a change in the business of Bonti, the new owners may use your personal information in the same manner as stated in this Privacy Statement

#### 10. International transfers

Some of the data processors of Bonti are overseas and located outside of the European Economic Area, so processing your data by them requires sending your data outside of the European Economic Area, which may not provide the same level of protection the jurisdiction in which you are based provides. If personal data needs to be transferred outside of the European Economic Area, we make sure that the following safeguards are in place, as required by data protection laws, to ensure that the same degree of protection is in place by our country's laws:

- In cases where we use suppliers or providers of specific services, we are required to use the standard clauses of the European Commission.
- If you would like to receive general information or information about the specific mechanism used by Bonti when transferring your data outside the European Economic Area, contact Bonti.





# 11. Information security

Bonti has taken appropriate security processes to prevent accidental loss, unauthorized use or access, alteration, or disclosure of your personal information.

In addition, Bonti restricts access to your data to employees, agents, contractors, and other third parties. They only process your data according to the instructions of Bonti and they are required to remove the privacy of your personal information.

Bonti has procedures in place to deal with any suspected breaches of personal data, and we will notify you and any relevant regulator of breaches that were legally required to do so.

### 12. Data retention

Bonti will use and retain your data for the purposes we have collected, including any legal, accounting, or reporting requirements that may be necessary.

To determine the appropriate retention period for personal data, the amount, nature, and sensitivity of personal data, the potential risk of harm resulting from the unauthorized use or disclosure of your data, and the purposes for which they process your data. However, Bonti can determine this period through effective factors and applicable legal requirements.

In some cases, you can ask Bonti to delete your data. Bonti may also anonymize your data for research or statistical purposes (so that it can no longer be related to you) in which case we may use this information indefinitely without further notice to you.

# 13. Your legal rights

You have the right to use the following rights under the Privacy Policy about your data:

- Request access to your personal information. In this case, you will be provided with a copy of the personal data that you and Bonti are legally allowed to process.
- Request to edit the personal information we hold related to you. This
  will allow you to edit any incomplete or inaccurate information that
  Bonti holds, although it may be necessary to verify the new data that
  you provide to Bonti.
- Correcting your information request Allows you to ask Bonti to delete
  personal data where there is no good reason to continue processing
  it. You also have the right to ask Bonti to delete your data in cases in
  which you have asked to delete the data but Bonti still is processing
  that. Please note that Bonti may not be able to delete your information
  for some specific legal reasons that will be notified to
  you at the time of your request.
- Where Bonti relies on legal interests (or the interests of a third party) and there is something about your particular situation that makes you want to object to the processing or oppose the processing of your data because you think Your circumstances are affected. You also have the right to object where Bonti processes your personal information for direct marketing purposes. In some cases, it may show compelling legal reasons for processing your information that disregard your rights and freedoms.





- Request restrictions on personal data processing. Allows you to ask Bonti to suspend the processing of your data in the following cases:
  - If you want to determine the accuracy of the data
  - In cases where the use of data by Bonti is illegal, but you do not want Bonti to delete it.
  - Where you need Bonti to maintain data, even if it no longer needs it because you need it to enforce or defend legal claims.
  - You have objected to the use of your data by Bonti but should consider whether you have a legitimate legal reason to use it or not.

# Request the transfer of your data to you or a third party

Bonti provides your personal information to you or a third party of your choice in a structured, customizable, readable format. Please note that this right only applies to information that you initially consent to. You have used it or in cases where they have used the information to contract with you.

You can cancel your consent whenever Bonti relies on consent for the processing of your data. However, this will not affect the legality of the processing done before your consent is revoked. If you withdraw your consent, we may not be able to offer you specific products or services. If you wish to exercise any of the above rights, please contact Bonti.

You will not have to pay to access your data (or exercise any other rights). However, if your request is unfounded, duplicated, or excessive, Bonti may charge a reasonable fee. On the other hand, Bonti may refuse to comply with your request in this situation. Bonti may need to request specific information from you to help the company verify your identity and ensure your right to access your personal information (or other rights). This is a security process to ensure that personal data is not disclosed to anyone who does not have the right to receive it. They may also contact you to ask for more information about your request for an expedited response.





Bonti tries to respond to all legal requests within a month. Sometimes if your request is complicated or you have several requests, it may take more than a month, in which case they will notify you and let you know.
